IADC Rig Moving Committee 18 May 2011

**Host: ACME Trucking** 

**Location: OMNI Houston Westside, Houston, Texas** 

Agenda Item: Welcome and Introductions

Justin Hodges, Committee Chairman opened the meeting and thanked Patrick Connelly, Acme Truck Lines for hosting the meeting. Joe Hurt gave the hotel safety briefing and other information regarding the hotel. Justin then asked the attendees to introduce themselves, see the attendance list.

### Agenda Item: General Discussion - Safety Minute - Best Practices

Justin Hodges – Opened the floor for general discussion, safety alerts & best practices. Some issues discussed are:

- Discussion was held on a Safety Alert issued by IADC regarding a floorman who was pinned between a truck and equipment. This led to discussion on other similar incidents and on methods to prevent this from happening.
  - One attendee is considering installing back-up cameras and beepers as means to mitigate pinned between accidents.
- There was discussion on tightening web straps over loads using the ratchet type device that utilizes a bar to turn. Some attendees reported that injuries are increasing due to use of the bar. Some companies are considering using a winch type of ratchet instead of the bar type to tighten straps.
- One company reported on a hand injury that occurred when a swamper tripped while walking near
  the outrigger and he placed his hands on outrigger to catch his balance as outrigger is being drawn
  in pinching his hand.
- There was discussion of an incident when a crane toppled forward while lifting a rig floor doghouse.
- There was discussion on an operator's initiative in Environmental Excellence especially in the Northeast. No spills at all. No more transporting loose drums on flatbed trailers. Must find other means to transport liquids and wastes. This led to discussions on best methods to transport drums. Some attendees stated that they review the loads and inform the rig owner if there any drums that they cannot move the load.
- Another new environmental initiative which was discussed at the IADC Environmental Conference
  in Trinidad creates a simplified method that's rates well sites. The system uses a new labeling
  system resembling ingredients in food products. Each chemical and quantities will need to be
  documented.
- There was a discussion on requirements to carry MSDS for all quantities of liquids hauled over the
  road that is being heavily enforced by regulatory agencies. Consensus of members was that it is
  best to call the supplying vendor or a 3rd party waste management company to handle the
  transportation of liquids.
- Near Miss 3 stack beams were being cleaned and loaded onto a truck bed during rain event.
   During loading, top beam slipped off onto the truck bed and then onto the ground. No injuries.
   Corrective action was to use 4x4 instead of 2x4 to provide better stability of beams and allow the forklift truck forks easier access to each beam.
- Discussion was held on CSA letters from FMCSA that are being sent to trucking companies advising them of being above the threshold and what the increased enforcement actions are.
- Suggestion was made to contact local DOT office for pre-inspection prior to rig movement.
  - Suggestion was made to provide incentives to drivers for clean inspections.
  - There was also discussion on problems getting DOT officers to issue clean inspection reports when they inspect a truck that has no violations. This is important to truckers because it helps to reduce their score under the new CSA system.
- One attendee discussed a problem they had with pressed on fittings (swedge fittings) on winch lines. The swedge fittings were breaking/splitting down at the midline at the button.
  - o A Suggestion was made to change vendors if it's a reoccurring problem.



• Member mentioned they were having their chains re-pull tested. They found some 3/8" chain rated for 24,000lbs actually broke at 18,000lbs.

## Task Group Report Work on Swamper Competency Syllabus

Joe Hurt explained that the task group has finished the competency document and provided a summary of it to the attendees. Once all the final changes are made, the document will be sent to the committee members who provide rig moving services for their approval. Once this document is approved it planned to table implementation until the committee completes a Gin Pole Truck Operator Competency Syllabus.

#### Some additional recommendations are:

- Suggestion made to give new hires the job description.
- Suggestion made to add "hire date" to top of document.
- The committee decided to remove "Start Date" column form the evaluation from.
- Suggestion made to make create a familiarization video for new hire swampers.
- Suggestion made to create a formal training program for swampers.
- Suggestion made to create a training disk for all job titles (swampers, gin pole truck drivers, etc.) once all syllabus are created.
- Question to group Anyone have a good training provider or program to share? If so, send their information to Joe Hurt at joe.hurt@iadc.org.
- Based on discussion a number of the attendees were creating their own training DVDs.
  - Joe discussed the NIOSH videos available from NIOSH on Move It, Seat Belts, and fall protection. Joe has some copies that he can send to those seeking one.
  - AZ informed the attendees that NIOSH working on new video for Rig Moving focusing on the truck driver.
- There was discussion on forming a task group to work on a competency program for the Gin Pole Truck Operator. Joe asked for volunteers to work on the project. The following offered to serve on the task group.

There was a discussion of the use and development of JSAs. To start off the discussion of JSAs a Rig Move, a JSA handout was given to group. Discussion was held on what is a JSA as opposed to a Job Procedure. The attendees were asked if they would provide examples of their JSA Program to the committee for future discussion. Member discussion continued regarding difference in JSA programs, usage, documentation and variations in JSAs. Justin commented that he has a document he received at a Contractor HSE Symposium held by an operator on JSA "Good Practices" that he would make available to the group.
