**OTHER DECISIONS* OF THE THIRTIETH REGULAR SESSION OF THE ASSEMBLY
AND RESOLUTIONS ADOPTED**

1 ADOPTION OF THE AGENDA (agenda item 1)

The Assembly adopted the agenda (contained in document A 30/1) as well as the proposed timetable (contained in document A 30/1/1) as recommended by the Meeting of Heads of Delegation.

**2 ELECTION OF THE PRESIDENT AND THE VICE-PRESIDENTS OF THE
ASSEMBLY (agenda item 2)**

2.1 The Assembly noted the information set out in document A 30/2, and that provided orally by the Secretary-General, on the election of the President, a first Vice-President and a second Vice-President, in accordance with rule 20 of the Rules of Procedure of the Assembly.

2.2 The Assembly elected the following officers to hold office until the thirty-first regular session:

President of the Assembly: His Excellency Mr. Rolando Drago Rodríguez (Chile)

First Vice-President: His Excellency Mr. Euripides L. Evriviades (Cyprus)

Second Vice-President: Her Excellency Ms. Tamar Beruchashvili (Georgia)

2.3 The Plurinational State of Bolivia made a statement regarding the election of the President of the Assembly, in which it expressed its dissatisfaction with the consultation process, at the regional level, for the nomination of a candidate from Chile. The Plurinational State of Bolivia abstained from voting but declared that, in keeping with the principle of cooperation, it would not stand against the election of the Chilean candidate as the President of the Assembly. 3 APPLICATION OF ARTICLE 61 OF THE IMO CONVENTION – REPORT OF THE COUNCIL TO THE ASSEMBLY ON ANY REQUESTS BY MEMBERS FOR WAIVER (agenda item 3)

3.1 The Assembly noted the information set out in documents A 30/3, A 30/3/Add.1 and A 30/3/Add.2, as well as that provided orally by the Secretary-General, on the Application of Article 61 of the IMO Convention, and the report of the Council to the Assembly on requests by Members for waiver of Article 61.

3.2 The Assembly waived the provisions of Article 61 of the IMO Convention in respect of the Union of the Comoros, the Commonwealth of Dominica and the Federal Republic of Somalia.

3.3 The Assembly noted that:

- (i) the Kingdom of Cambodia, the Democratic Republic of the Congo, the Dominican Republic and the Federal Democratic Republic of Nepal had settled their arrears up to 2016 in full. As a consequence, these Member States no longer fell under the provisions of Article 61 and their voting rights were thus restored during this Assembly; and
- (ii) the seven remaining Member States which had not sought a waiver (listed in annex 1 to document A 30/3/Add.2) had lost their right to vote during this Assembly, and the right to vote would be reinstated as soon as the Member States concerned settled their arrears.

3.4 The Assembly reiterated its firm stance on the strict enforcement of Article 61 of the IMO Convention.

3.5 The Assembly noted that all of the 46 candidates which had indicated their intention to stand for election to the Council had met the requirements of rule 56*ter*.

3.6 The Assembly noted and adopted the Council's recommendation that, where a Member State submits a request for a waiver of arrears, the Assembly should consider the matter only where a request for a waiver has also been submitted to the United Nations General Assembly and a decision has been taken by that body on that request. The Assembly may then decide on the request for such a waiver, taking into account any precedent established by the United Nations General Assembly.

6 REPORT OF THE COUNCIL TO THE ASSEMBLY ON THE WORK OF THE ORGANIZATION SINCE THE TWENTY-NINTH REGULAR SESSION OF THE ASSEMBLY (agenda item 6)

6.1 The Assembly noted the information set out in documents A 30/6 and C/ES.29/D, and that provided orally by the Chair of the Council on the report of the Council to the Assembly on the work of the Organization since the twenty-ninth regular session of the Assembly.

6.2 The Assembly:

- (i) approved the report of the Council on the work of the Organization since its twenty-ninth regular session, submitted by the Council in accordance with Article 23 of the IMO Convention; and
- (ii) endorsed the decisions taken by the Council relating to measures to prevent acts of endangering the safety of navigation, as set out in paragraphs 15(b).2 and 15(b).3 of document C/ES.29/D.

6.3 With regard to paragraph 6.2(ii) above, the Democratic People's Republic of Korea made a statement objecting to the Council's decision, taken at C/ES.29, that missile launches by the Democratic People's Republic of Korea posed a danger to the safety of shipping. In summary:

- The Democratic People's Republic of Korea stated that its missile launches were intended to be a response and defensive measure to the United States of America's military exercises around the Korean peninsula, which the Democratic People's Republic of Korea perceived as a military and nuclear threat.
- Furthermore, in the view of the Democratic People's Republic of Korea, the United Nations Security Council resolutions against its missile launches, upon which the C/ES.29 decision appeared to have been based, were illegal for a number of outlined reasons, including that the United Nations Security Council was not a legislative organ capable of creating international law.
- The Democratic People's Republic of Korea suggested that the Assembly should reject the C/ES.29 decision against its missile launches, and requested that Member States' attention be drawn to the compelling need and urgency to restrain the on-going large-scale joint military drills, in order to secure the safety and efficiency of international shipping.

8 IMO MEMBER STATE AUDIT SCHEME (agenda item 8)

8.1 The Assembly noted the information set out in documents A 30/8 and A 30/8/1 (Tunisia), and that provided orally by the Secretary-General and the delegation of Tunisia, on the IMO Member State Audit Scheme.

8.2 The Assembly referred both documents, in light of comments made, to Committee 2 for detailed consideration and, upon the recommendation of the Committee:

- (i) invited Member States scheduled to be audited after 2018 and who were prepared to have their audits brought forward to inform the Secretary-General as soon as possible;
- (ii) encouraged Member States to provide the Secretariat with the details of an individual authorized to access Member State audit reports through the GISIS module as per Circular Letter No.3587;
- (iii) requested the Maritime Safety Committee and the Marine Environment Protection Committee to consider the first Consolidated Audit Summary Report (CASR) containing lessons learned from 18 mandatory audits completed in 2016 (Circular Letter No.3772) and, in due course, to advise the Council of the outcome of their consideration;
- (iv) invited those Member States whose target deadlines for the implementation of their corrective action plans had been reached to provide the Secretariat with their comments on the progress made on the implementation of their corrective action plans;
- (v) encouraged auditors to update their profiles in the E-roster and for individuals nominated for inclusion in the roster of auditors and for the Member State nominating such individuals to use the procedures set out in Circular Letter No.3547;
- (vi) noted Tunisia's intention to continue to support IMO's technical cooperation activities, in particular with regard to the IMO Member State Audit Scheme; and
- (vii) invited the Technical Cooperation Committee to consider the need to focus technical assistance towards those areas of recurrent findings from audits of Member States.

8.3 The Assembly welcomed the progress made in the implementation of the Audit Scheme over the previous two years and expressed its appreciation to those Member States that had been audited or were in the process of preparation for the audit, for their full cooperation, as well as to those Member States that had nominated auditors for inclusion in the roster of auditors maintained by the Secretariat.

11.3 The Assembly recognized the ongoing problem of marine plastic pollution, as addressed in MARPOL Annex V, which requires further consideration as part of a global solution within the framework of ocean governance, in pursuance of SDG 14's target to prevent and significantly reduce marine pollution of all kinds by 2025. The Assembly referred document A 30/11/1, together with the comments made in plenary, to MEPC 72 and LC 40/LP13 for detailed consideration and action as deemed necessary.

11.4 In recognizing the role that the Organization has and continues to play in addressing this problem, the Assembly encouraged Member States, Parties to MARPOL Annex V and international organizations to submit concrete proposals to the competent bodies, MEPC 72 and LC 40/LP 13, taking into account those widely supported proposals in paragraphs 24 and 25 of document A 30/11/1, in accordance with the Committees' Method of Work.

17(a).2 The Assembly urged Member States and Associate Members to take action to enable recognition, under their national legislation, of the degrees conferred by the University and, to that end, keep the Organization informed of any developments.

17(a).3 The Assembly strongly urged Member States and shipping industry stakeholders to contact WMU to establish what they could offer, including fellowships for students from developing countries and with respect to the equipment needs for the academic facilities of the University.

17(a).4 The Assembly expressed its appreciation to the Government of Sweden, and to all other donor Governments and organizations, for their continued support of the University and, in particular, to the City of Malmö for hosting the University and for providing the new academic premises of the University.

17(a).5 The Assembly further expressed its appreciation to those donors who had contributed to the WMU Endowment Fund and urged Governments, organizations and the maritime industry to provide financial contributions to the Fund.

Proposed amendments to the Charter of the World Maritime University

17(a).6 The Assembly noted the information set out in document A 30/17(a)/1 and that provided orally by the Secretary-General on proposed amendments to the Charter of the World Maritime University.

17(a).7 The Assembly adopted, pursuant to the provisions of Article 44(a) of the Charter of the World Maritime University, the resolution on the *Charter of the World Maritime University*, containing amendments to the University's Charter, as set out in the annex to document A 30/17(a)/1, and decided that those amendments would enter into force on 1 January 2018.

17(a).8 The Secretary-General, in his capacity as WMU Chancellor and also as Secretary-General, expressed his appreciation to the University's President, its Vice-Presidents and the WMU academic and administrative staff for their work, commitment and dedication, as well as the Members of the WMU Board of Governors and the Chairman and Members of the WMU Executive Board for their continuing constructive support to the University.

17(b).4 The Assembly urged Member States to take action so as to recognize, under their national laws, the degrees conferred by the Institute and to inform the Organization of such action.

(a) Relations with the United Nations and the specialized agencies (agenda item 18(a))

18(a).1 The Assembly noted the information set out in documents A 30/18(a) and A 30/18(a)/1, and that provided orally by the Secretary-General, on relations with the United Nations and the specialized agencies.

18(a).2 The Assembly noted the report of the Secretary-General on relevant cooperative activities with the United Nations and the organizations and bodies within the United Nations system, in particular the Organization's representation at various meetings of United Nations entities and the efforts made by the Secretary-General and the Secretariat to promote the interests of IMO in the relevant areas.

18(a).3 The Assembly also noted the reports on the activities and achievements of the Joint Group of Experts on the Scientific Aspects of Marine Environmental Protection (GESAMP), and expressed its appreciation for the scientific advice, with respect to the protection of the marine environment, provided by GESAMP in support of the Organization's objectives.

18(b).2 The Assembly took note in particular of the consideration by the Council of the reports of the Joint Inspection Unit referred to in document A30/18(b), and the information provided on the action taken on these reports and additional remarks provided by the Secretary-General.

18(d).2 The Assembly endorsed the decisions of the Council concerning applications for consultative status with the Organization. Accordingly, the Assembly:

- (i) agreed not to proceed with the applications from the Society for Gas as a Marine Fuel (SGMF), the International Sailing Schools Association (ISSA), the International Cruise Victims Association (ICV), the Methanol Institute (MI), the Union of African Shippers' Councils (UASC), the International Ship Engineering Service Association Ltd. (ISES), the Project Developer Forum (PD-Forum), the International Grain Trade Coalition (IGTC) and Stop Illegal Fishing (SIF);

- (ii) noted the decision of the Council to request the International Association of Technical Survey and Classification Institutions (TSCI) to submit further information for consideration at its 120th session; and
- (iii) approved the granting of consultative status to the Active Shipbuilding Experts' Federation (ASEF) and The Pew Charitable Trusts (Pew).

18(d).3 The Assembly endorsed the decisions of the Council to maintain the consultative status of the organizations listed in document C 118/17(d)/1.

18(d).4 The delegations of the Bahamas and the United Kingdom, expressed their concern with Greenpeace International's recent protest activities involving a Bahamas flagged ship in United Kingdom waters which, in their view, endangered the safety of navigation and maritime security. The Assembly requested the Secretariat to write to Greenpeace International to remind it of its obligations in respect of these matters.

18(d).5 The Assembly adopted the resolution on *Relations with non-governmental organizations*, set out in the annex to document A 30/18(d)/1, with an update on the name of IPIECA, which was changed from "International Petroleum Industry Environmental Conservation Association (IPIECA)" to "IPIECA Limited (IPIECA)".

(e) Report on World Maritime Days, 2016 and 2017 (agenda item 18(e))

18(e).1 The Assembly noted the information set out in documents A 30/18(e) and A 30/18(e)/1 (Panama), and that provided orally by the Secretary-General and the delegation of Panama, on the celebration of World Maritime Day in 2016 and 2017.

18(e).2 The Assembly noted, with satisfaction, that World Maritime Day had been successfully celebrated at IMO Headquarters during the biennium and welcomed the information on Member States' national celebrations. The Assembly expressed its appreciation to the Secretary-General and the Secretariat for the efficient arrangements made to ensure the successful celebration of IMO's annual Day.

18(e).3 The Assembly also expressed its appreciation to all Governments and organizations which contributed, in many ways, to the celebration of this annual event, including their continuing efforts to publicize and promote the event thus making it more widely known.

18(e).4 The Assembly in particular expressed its appreciation to the Governments of the Republic of Turkey and the Republic of Panama for successfully hosting the World Maritime Day parallel events in 2016 and 2017.

18(e).5 With regard to the forthcoming World Maritime Day parallel events, the Assembly, once again, expressed its appreciation to the Governments of Poland, Colombia, South Africa and the Islamic Republic of Iran for their invitations, and noted that the next consideration of offers to host the parallel event would be in 2018 for 2022.

18(e).6 The Assembly noted, with appreciation, document A 30/18(e)/1, submitted by Panama, including a report on a high-level round-table discussion held within the framework of the IMO World Maritime Day parallel event in Panama City, Panama, on 2 October 2017. In this regard, the Secretary-General expressed his wish for other high-level round-table discussions to be initiated at future parallel events so as to promote more awareness and cooperation within the scope of the IMO mandate.

18(e).7 The Assembly noted and endorsed the theme for World Maritime Day 2018, as determined by the Council at its 117th session, namely, "IMO 70: Our Heritage – Better Shipping for a Better Future", and requested that the Secretary-General emphasize the concept of "sustainable shipping" when promoting the theme. The Assembly also noted that the objective of sustainable shipping would underpin all activities throughout 2018 and beyond.

The Assembly also expressed its appreciation to the Government of Japan and the Comité Maritime International for having nominated such worthy candidates. The Assembly further noted the arrangements made in connection with the award of the Prize for 2017.

18(g).2 The Assembly noted, in particular, the information provided by the Secretary-General on the 2016 and 2017 IMO Awards for Exceptional Bravery at Sea and congratulated Captain Radhika Menon (nominated by the Government of India), the recipient of the 2016 IMO Award for Exceptional Bravery at Sea; and also congratulated Captain Michael G. McGee and Captain Michael C. Phillips (nominated by the International Maritime Pilots' Association), the recipients of the 2017 Award. The Assembly expressed its appreciation to all other recipients of awards within the scheme, as well as to those Governments and international organizations which nominated such worthy candidates for the Awards in 2016 and 2017.

18(g).3 The Assembly commended the Secretary-General for the successful organization of both Award ceremonies, the first of which took place in 2016, during the ninety-seventh session of the Maritime Safety Committee, and the second, at the end of the first day of the thirtieth session of the Assembly.

18(g).4 The Assembly expressed its hope that the current situation of mixed migration by sea and significant loss of life would soon be brought under control, and recognized and praised all those seafarers supported by their shipping companies, who, out of humanitarian concern, continued to make heroic efforts to rescue thousands of persons in distress at sea.

18(g).5 The Assembly endorsed the arrangements outlined by the Secretary-General for the 2018 IMO Award for Exceptional Bravery at Sea.

18(i).2 The Assembly noted in particular document 30/18(i)/1 outlining the activities of the IMO Maritime Ambassadors and requesting a proposal for the development of a framework for the IMO Maritime Ambassador Scheme and the establishment of an appropriate resource mechanism, following the request from C/ES.29 to the Secretary-General to conduct a programme evaluation and comparison analysis with similar schemes within the United Nations system and submit a report to C 120.

18(i).3 The Assembly expressed its appreciation to all those who had appointed IMO Maritime Ambassadors and encouraged Member States that had not yet done so to appoint an IMO Maritime Ambassador.

19 REPORT ON THE STATUS OF THE CONVENTION AND MEMBERSHIP OF THE ORGANIZATION (agenda item 19)

19.1 The Assembly noted the information set out in documents A 30/19 and A 30/19/1 (International Mobile Satellite Organization (IMSO)), and that provided orally by the Secretary-General and the Director-General of IMSO, on the status of the Convention and membership of IMO and IMSO, respectively.

19.2 The Assembly encouraged, endorsed and supported the Secretary-General in his efforts to make IMO and its work more widely known and to ensure that it maintained its deserved position in the global maritime community. The Assembly also encouraged the Secretary-General to continue to assist all Member States, in particular developing countries, in participating fully and effectively in the work of the Organization. The Assembly extended a very warm welcome to the Republic of Belarus, the newest member of IMO.

19.3 The Assembly noted the current membership of IMSO and encouraged IMO Member States that are not yet Member States of IMSO to give consideration to joining that organization.

20 REPORT ON THE STATUS OF CONVENTIONS AND OTHER MULTILATERAL INSTRUMENTS IN RESPECT OF WHICH THE ORGANIZATION PERFORMS FUNCTIONS (agenda item 20)

20.1 The Assembly noted the information set out in documents A 30/20, A 30/20/Add.1 and A 30/INF.7 (International Chamber of Shipping (ICS) and Comité Maritime International (CMI)), and that provided orally by the Secretary-General, on the status of conventions and other multilateral instruments in respect of which the Organization performs functions.

20.2 The Assembly endorsed and supported the Secretary-General's continuing efforts to encourage Governments to consider accepting those instruments to which they were not yet parties.

20.3 The Assembly reiterated its plea to Member Governments to ratify the 2009 Hong Kong Ship Recycling Convention, the 2010 HNS Protocol, and the 2012 Cape Town Agreement, to enable their entry into force as soon as possible.

20.4 The Assembly welcomed the entry into force of the 2004 Ballast Water Management Convention, on 8 September 2017, and in this regard, endorsed the Secretary-General's request for further ratifications so as to achieve widespread effective implementation and enforcement.

20.5 With regard to document A 30/INF.7, the Assembly noted the information regarding the campaign by ICS and CMI campaign to promote the ratification of a number of international maritime conventions, so as to achieve global standards enforced worldwide on a uniform basis. The Assembly expressed its appreciation to ICS and CMI for the information provided.

21.1 The Assembly noted the information set out in documents A 30/21, A 30/21/1, A 30/21/1/Add.1, A 30/21/2 (Ukraine) and A 30/21/3 (Guatemala), and that provided orally by the Secretary-General and the delegations of Ukraine and Guatemala, on the election of the Members of the Council, as provided for in Articles 16 and 17 of the IMO Convention.

21.2 With regard to document A 30/21/3, the Assembly agreed with the proposals by Guatemala and, in accordance with rule 37 of the Rules of Procedure of the Assembly, decided to:

- (i) at all times, conduct the elections of the Members of the Council by secret ballot, even where the number of candidates seeking election was equivalent to the number of available seats; and
- (ii) discontinue the practice of electing Members of the Council by acclamation.

21.3 The Assembly noted the comments received from Member States on possible changes to the relevant rules of the Organization in relation to the work of the Council, and decided that detailed proposals on such changes be submitted for consideration at C 120.

21.4 In accordance with Articles 16 and 17 of the IMO Convention, the Assembly elected Members of the Council as follows:
